SOMALI COMMUNITY ENGAGEMENT (SCE) develops, implements, and hosts various arts events, series, projects, and programs in partnership with other organizations to serve the East African immigrant communities of the Twin Cities Metro Area, focusing on residents of the Cedar Riverside neighborhood. These efforts include increasing access to the arts through ticket giveaways, strategic marketing, and special programs; workshops and presentation series that preserve traditional East African art forms; and working with partner organizations to identify community challenges and utilize the arts to address these problems.

Our biggest accomplishment in the SCE program came in January of 2012 when

416 CLUB COMMISSIONS commissions local artists to create and present new work at The Cedar. 2012 launched 416 Club Commissions second cycle. The Cedar assembled a committee of artists, arts administrators, and other individuals from the local arts community to review nominations and applications after an extensively advertised request for proposals. This second cycle invited artists to submit their resume, a description of their concept and approach, and several work samples. We received 59 applications. After reviewing the applications, the committee held discussions about each artist and chose seven to create half an hour of new music. The seven artists represent a diversity of cultures, ages, instruments, and training backgrounds. Our new tool, Cedar Seeder, has
