To engage Somali elders, a group with whom we haven't before worked, we hosted several events specifically targeting Somali women, and a series of storytelling workshops for elders. We partnered with a local adult day care facility to engage this target audience of elderly Somali women. Many of them have physical limitations and challenges. To ensure their participation, we provided door-to-door transportation and one-on-one help to exit and enter the vehicles and program spaces and to ensure their comfort. We also adjusted start and end times for many events to accommodate the Somali community's culture of staying out late for social events.
